Parcel A: Located in Section 36, Township 24 South, range 26 East, in the County of Tulare APN: 340-070-16 (10.04 acres). Parcel B: Located in Section 6, Township 25 South, Range 27 East, in the County of Kern APN: 051-090-29 (1.96 acres). Parcel C: Located in Section 32, Township 25 South, Range 27 East, in the County of Kern APN: 051-132-35 (10.00 acres). Total of 22.0 acres.*

Unless written opposition to this proposal is received before the conclusion of the Commission proceedings, the Commission intends to waive protest proceedings on this proposal. Please note that there may be potential for the extension or continuation of any previously authorized charge, fee, assessment, or tax by the local agency in the affected territory.
